TOPICS:

Presentation of 604th CGAS new troops organization: The bulk of new member applications are from South Capiz, specifically in Dumarao and Dumalag. Once inducted, the process of establishing a new South Capiz Division will commence. It will likely be assigned as the 604.5 Auxiliary Division.

Schedule of induction of new members and awarding ceremony: It was determined that the target date for the inductions and awards ceremony will be Saturday, 26 OCT 2024. A representative from CGADWV will be requested to attend. Details TBD.

Promotion of deserving officers: The format for promotions was distributed to the squadron and all but a few members meet TIG (Time In Grade) requirements for a promotion. Previous promotion packages were created and submitted on behalf of members based on eligibility and activity participation. This was found to be inappropriate, as a number of the last promotion recipients weren't seeking promotion. This time, SSHR and DDASA are assisting with member submissions only when requested.

Updates on 604th mandatory activities: It was previously determined that a monthly squadron meeting should be conducted. To facilitate improved squadron member interaction and communications, it was decided that Java Tuesdays would be instituted to provide a weekly opportunity for member interaction. The first was scheduled for 01OCT2024 location TBD.

It was also discussed that Squadron Staff (SS) positions for MAREP, MARSAF, MARSAR, and COMREL should schedule activities in advance each month so that these activities can be more effectively coordinated with PCG and the various impacted organizations. SS officers are encouraged to enlist other officers and members to assist in scheduling and conducting these activities.

Upcoming 40th PCGA NACON: CGADWV is hosting the next PCGA NACON, to be held April 25th and 26th at the Iloilo Convention Center. 604th CGAS was originally responsible for the registration process, but that has been shifted to the Financial Chairman of NACON, so our responsibilities are greatly reduced. 604th CGAS is responsible for the check-in process of registrants. We will need members to man the check-in tables, with most of that activity occurring in the morning and throughout the day of 25 APR 2025.

Financial Report: AUX LCDR LEONARD W GEMAR PCGA, DDASA provided the current status of squadron finances as follows. Current funds on hand are ₱11,759.82, ₱3,838.32 in the East/West account managed by AUX CDR BRIAN JOSEPH L CASTAÑEDA PCGA with the balance of ₱7,921.50 managed in a G-Cash account by AUX LCDR LEONARD W GEMAR PCGA.

It was also discussed that 604th CGAS officer dues were only received from 23 of 50 officers for 2024. It was determined that those who don't bring their 2024 dues current this year and then don't pay their 2025 dues in January will be dropped from the roster. Those officers who remain two years in arrears will be deactivated from PCGA per the **PCGA Regulation Manual 2021, Chapter 3 MEMBERSHIP, Section B ENROLLMENT, Paragraph 2 Re-Enrollment (Page 21)**.

AUX CDR DENNIS A SANELO PCGA requested that AUX LCDR LEONARD W GEMAR PCGA send him the list of delinquent officers for follow-up. This was provided during the meeting.
